Cookies are a piece of data sent from a website and stored in your browser's memory. Necessary cookies

Necessary cookies are used to make a website work properly, generally not used for tracking and not shared across websites. The most common action performed using a cookie is user authentication. When you access any website, a cookie is stored in your browser that includes some data used by the web to remember who is authenticated when you go to another internal page or refresh the site. Cookies are also used so that a website knows what's in your cart, load balancing information, and more.

Preferences cookies

Preference cookies allow the website to remember information to personalize the appearance or behavior of the website for each user. This may include storing selected currency, region, language, or color theme.

Analytical cookies

Analytical cookies are not necessary but are used to gather valuable information on how a website is used, identify issues, and understand what needs improvement on the site and what content is helpful. The collected information is mostly anonymous, but some analytics services collect information that can be used to identify the user.

Marketing cookies

Marketing cookies are used to track visitors across websites to enable publishers to display relevant and engaging advertisements. This site uses various types of cookies and you can change or withdraw your consent at any time.
